## JULY 6, 2009 MINUTES of the 2009 ANNUAL MEETING of VALLEY VISTA OWNERS' ASSOCIATION

The meeting was called to order by our Vice President Rick Elbracht at 3:41pm at J Arthurs Restaurant loft; after introductions it was determined that we had a quorum. Minutes of last year were approved.

TREASURER REPORT: Andy gave the P&L Statement, Running Checkbook and Fact Sheet to the members. Report was approved.

TRACTOR: Our VP invited Gordon Rohloff to inform us more about the Tractor. Our John Deer was purchased last year for \$13,000 with a 0% loan over 4 yrs, \$286.52 per month. Insurance = \$220/yr. We have already saved much money due to the additional attention to the roads by Gordon & Rich. They are the designated insured drivers, and the tractor is for *Roadwork only*; not for private use. Our thanks to the crew who constructed the Shed for the tractor. It's a very durable building, costing only \$2300 due to the hard work of Merle Kroeplin, Dave Parsch, Gordon Rohloff, and Rich Cook who did the wiring. Over 60 hrs each during a 14 day period. Our Thanx!

<u>WATER</u>: Dave Phillipps was invited to update us about the water. Because of the constant attention of Rich Cook, the water is safe, plentiful, clean, clear and delicious! This past year the main water line was relocated for its safety from the freezing temps and large truck weight.....leaks fixed (at Kelly's)....water line repairs and additions at top of mountain.....new tanks installed, and new air bleeding valves in tanks....as well as sediment cleaning of all tanks. Thanks again Rich, for the work and a lot of constant monitoring of the water system, not to mention the managing of repairs and getting parts!

## **NEW BUSINESS**:

**SPRING BOXES**: Attention to the SPRING BOXES will start this year. This project will include a thorough inspection of each box, with repairs and (if necessary) new shingles to assure proper draining, keeping the elements and sediment out of the boxes to keep a superior quality of the water.

**ROAD PROJECT**: We will continue the road project from the Kelly house up to the switchback at the Rudich house. The culverts were put in last year, so this year the **outside edge** of the road will be **raised**, so water will run <u>down</u> to the culverts, **not down** the hill thru our properties.

<u>DOCUMENTS</u>: The changes to the COVENANTS & RESTRICTIONS that were passed at last years meeting have been included into a new document (which will be on our website and clearly located next to the original document) and were recorded in Haywood County. The "amendments" document will stand until 2013 when it will be consolidated in its entirety within the original documents. Changes to the BY-LAWS (not recorded at the county) will be consolidates with the original document.

NEXT MEETING: Quick discussion brought us to a FRIDAY, JULY 2<sup>nd</sup>, 2010 choice for our next year meeting. Ed Bourke will research some alternative locations, so for now the LOCATION will be announced at a later time. ELECTIONS: The nominating committee headed by Susan Youngs with Jeanie Ogden and David Wynn were appointed by our President Frank Ward last year. They nominated David Day, Rick Elbracht and John Ogden for the Board for a 3 year term (ending in 2012) Susan Youngs announced their nominations, and then asked for any additional nominations. Gary Schroeder's name was also placed in nomination. Election was held with paper ballot, resulting in the election of David Day, Rick Elbracht and John Ogden. They join the other 6 board members. See next page for more "Board" info. The Board met, and re-elected Andy as Treasurer / Sec, and re-elected Rick Elbracht as Vice President, and elected David Day as President. Frank Ward remains on the board as a director.
